ADVOCATE REPORT AND TRAINING:

Regional Manager Latoya Wilborne made the announcements:

1. Quarterly 4 Advocate Report October 1, 2024-December 31, 2024:

A.) Allegations/Complaints:

This Region has received 466 Abuse and Neglect allegations and 93 Complaints for a total of 559 reportable incidents within our CHRIS systems. Out of those 559 reportable incidents we have issued 76 citations.

OLD BUSINESS:

Harbor Point Behavioral Health Center –Variance Quarterly Update

Brandon Murrer- Brandon presented for quarter four.

- Restrictions on Freedoms of Everyday Life
 - No complaints or grievances.
 - Average level for the building was 3 of 5

Kempsville Behavioral Health Center- Variance Quarterly Update

Dana Gillentine-Dana presented for quarter four.

- Timeout- (Use of Unit Restriction Policy)
 - 6 incidents (12/7-24-12/8/24 due to self-tattooing with a needle and ink. The order was reviewed at 24hrs by physician and discontinued.)
 - 1 incident (12/31/24 for 24 hours due to aggression. The order was reviewed at 24hrs by physician and discontinued.)

New Business

Advocate Miracle Reed-Thompson completed LHRC training on Restrictions of Freedoms of Everyday Life.

CLOSED SESSION:

Motion was made by Norris Shermon and seconded by Michelle Logan at 1:33pm that the HPR5 LHRC will go into closed session pursuant to VA code 2.2-3711 (A), for the purpose of discussing confidential information lawfully exempt from public disclosure review to discuss a Restriction of Everyday Freedom and conduct LHRC interview.

RETURN TO OPEN SESSION:

The committee reconvene in open session at 2:43pm by unanimous vote on a motion by Norris Shermon and seconded by Michelle Logan. Each member certified that, to the best of each of their knowledge, only private business matters, lawfully exempted from the statutory open session requirements and identified in the motion by which the closed session was convened, were considered in the closed session, namely for the purposes to discuss a Restriction of Everyday Freedom and conduct LHRC interview.

Recommendation: Motion made by Norris Shermon, seconded by Ms. Cynthia Frazier and unanimously approved by the committee members as follows:

- 1.) Voted to recommend interviewee for LHRC membership
- 2.) Camera restriction was not approved by the LHRC as it was not enough data submitted to justify need.
- 3.) DePaul Community Resources must re-submit updated Restrictions of Everyday Freedom form to include updates for:
 - a. Verbiage-add "physical aggression"
 - b. Explain how Plexi glass will function
 - c. Explain purpose of harness
 - d. Address any AWAL concerns with harness?
 - e. Criteria for removal of seatbelt
 - f. Provide draft of plan
